

Terms and conditions of the drawing competition
"Yesterday, today and tomorrow"

1. General information

1. The aim of the competition is to depict an interpretation of the theme "Yesterday, today and tomorrow" through the eyes of a child by refugee, migrant and Polish children. A depiction of the integration of the host society with the refugee and migrant society in Poland is welcome.
2. The competition is organised by the Mother's Home operating within the framework of the Inna Przestrzeń Foundation (KRS 0000257224).
3. Entry to the competition does not affect other services offered by the Mother Home.

2. Participants in the competition

1. The competition takes place in three separate age groups and three social categories making a total of 9 categories:
 - a. Children under 7 years of age
 - i. Children from Poland
 - ii. Children from families of war refugees from Ukraine
 - iii. Children from migrant families, regardless of nationality
 - b. Children aged 7 to 14
 - i. Children from Poland
 - ii. Children from families of war refugees from Ukraine
 - iii. Children from migrant families, regardless of nationality
 - c. Young people aged 14 to 18.
 - i. Young people from Poland
 - ii. Young people from families of war refugees from Ukraine
 - iii. Young people from migrant families. regardless of nationality
2. Participants in the competition cannot be children of employees or residents of the Mother's Home, or children of persons connected in any way with the Mother's Home or the Other Space Foundation.
3. As the participants are minors, their rights are vested in their legal representatives. 3.

3. Conditions of participation

1. Participation in the competition is entirely voluntary and consists of:
 - a) Sending the competition work to the Organiser by e-mail without any refund and, in the case of receiving information about being a winner, in person;
 - b) providing the Organiser with personal data: first name, surname of the author, date of birth, place of origin and nationality, date of arrival in Poland and first name, place of origin and nationality, date of arrival in Poland and e-mail address and telephone number of the legal representative;
 - c) Granting the organiser permission to process personal data for the purpose of adjudicating the competition and contact data for possible contacts in the case.
 - d) Transferring to the Organiser, free of charge, full intellectual property rights, copyright and all related rights related to the submitted work, which means the possibility of unlimited use in time and manner by the Mother's House of this

- work for marketing or promotional purposes, without the possibility of any subsequent claims;
2. The theme of the competition: "Yesterday, today and tomorrow" is subject to the participant's free interpretation.
 3. One participant may submit only one entry. In the case of participants from families with many children, this requirement applies to each participant separately.
 4. Competition entries may be made in any art, graphic or drawing technique.
 5. Only works that have been made for the competition and have not been entered in other competitions, published or disseminated in any way prior to the announcement of the competition and will not be entered, published or disseminated after the conclusion of the competition. In the event of a breach of this condition, the entrant will be held entirely responsible.
 6. The work must not contain elements or parts of other works to which the participant does not have full copyright.
 7. Competition entries must be in a format no smaller than A4.

4. Entry to the competition

1. In order to enter, you must produce the work detailed in Article 3 of these rules and make an entry to the competition.
2. Entries can be made in three ways:
 - a. in person by delivering the work together with the completed form "Entry to the drawing competition "Yesterday, today and tomorrow" ", which is attached as Annex 1. to these Rules and Regulations,
 - b. by delivering the work together with the completed form "Entry for the "Yesterday, Today and Tomorrow" drawing competition ", which is attached as Appendix 1. to the present Rules and Regulations by post, courier or parcel post Inpost,

3. Deadline for entries: 25.05.2023r..
4. Winners of the competition who submit entries via the electronic form, after receiving notification of the outcome of the competition, shall be obliged to deliver the original work in person to the registered office of the Mother's Home: ul. Małego

Ryćerza 25 in Warsaw on the day of the prize-giving ceremony (1.06.2023), which is a condition for receiving the prize.

5. Artworks delivered without an attachment will not be taken into consideration.

5. Prizes

1. Nine prizes will be awarded in the competition - one in each category.
2. The Commission will select the winners from among the works that meet the highest aesthetic criteria and most interestingly reflect the theme of the competition in the context of social inclusion.
3. The prizes in the competition are toys and children's items with a value of at least PLN 500, adapted to the age of the participants. The total prize pool will amount to at least PLN 4,500. Due to the nature of the prizes, their unit value may vary slightly.
4. The condition for receiving the prizes is personal appearance on the day of the prize presentation, i.e. 1.06.2023r. at Dom Matki at ul. Małego Ryćerza 25 in Warsaw at an hour indicated by the organiser.
5. Prizes will not be sent by post. In the event that the winner does not appear, the organiser reserves the right to select another winner.

6. Competition schedule

1. Competition entries will be accepted from the date of the competition announcement in social media and on the Organiser's website until 25.05.2023
2. The competition will be decided for each category (9) separately, by 27.05.2023 by a competition committee appointed by the Organiser. There is no right of appeal against the commission's decisions.
3. The winners will be notified of the outcome of the competition by 29.05.2023 by telephone on the number provided with their application. The organiser reserves the right not to notify the other participants.
4. The presentation of prizes will take place during the Grand Celebration on Children's Day on 1.06.2023, the exact time of the prize presentation will be communicated to the winners together with the notification of the outcome.

7. Personal data

1. The organiser reserves the right to:
 - a) To correspond with a person by telephone or email on matters relating to the competition;
 - b) Use the works submitted to the competition for purposes related to its statutory activities, which does not apply to contact details.
2. Processing of personal data. In accordance with Article 13 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (RODO), I inform you that:

- c) The processing of data exclusively for the purpose and scope specified above is based on the person's consent Article 6(1)(a) RODO.
- d) Once the work has been submitted, consent can only be withdrawn with the consent of the Administrator;
- e) The provision of one's data is entirely voluntary and failure to do so will exclude the possibility of participating in the competition.
- f) Personal data will not be processed by automated means or transferred to countries outside the scope of the RODO, which clearly does not apply to the data covered by the publication;
- g) A person has the right to: access to the content of his/her data, rectification, restriction of processing, the right to withdraw consent at any time without affecting the lawfulness of the processing (if processing is based on consent) that was carried out on the basis of consent before its withdrawal; to lodge a complaint with the President of the Office for the Protection of Personal Data if he/she considers that the processing of personal data violates the provisions of the RODO.
- h) The right: under Article 17(3)(b) or (e) of the RODO to erasure of personal data; Article 21 of the RODO the right to object, to the processing of personal data; Article 20(1)(b) data portability does not apply.
